<u>Treating septic tanks:</u> (1) Pour the dose of **Nu-Sept™** in the toilet bowl then flush.

Treating portable toilets: (1) Empty and clean the tank of the toilet. (2) Add the amount of water specified in the instructions. ⓐ Pour the dose of **Nu-Sept™** directly in the tank. (4) Add another dose two days later if necessary. (5) At every visit, spray three to four squirts of Nu-Smell Plus™ on the floor.



## **Technology**

By preventing the growth of bacteria that produce hydrogen sulfide (H2S), our bacterial cultures prevent conditions such as foul odours and improper functioning of the septic tank. When organic matter is broken down faster and the septic system is healthier in general, both the tank and the disposal field can achieve peak operating conditions.
